Notification of Amendment to Input Methodologies for Electricity Line Services and Gas Pipeline Services

The Commerce Commission ("Commission") has amended the input methodologies applicable to electricity lines services and gas pipeline services under Part 4 of the Commerce Act 1986.

The amended input methodologies are:

- *Electricity Distribution Services Input Methodologies Determination 2012* [2012] NZCC 26*

- *Transpower Input Methodologies Determination* [2012] NZCC 17†
- *Gas Distribution Services Input Methodologies Determination 2012* [2012] NZCC 27*
- *Gas Transmission Services Input Methodologies Determination 2012* [2012] NZCC 28*.

The amendment is set out in the *Electricity Lines Services and Gas Pipeline Services Input Methodologies Determination Amendment (WACC percentile for price-quality regulation) 2014* [2014] NZCC 27, and will apply to price-quality path regulation for electricity lines services and gas pipeline services.

The Commission has changed the percentile that applies in determining estimates of the weighted average cost of capital that will apply for price-quality regulation for electricity lines services and gas pipeline services.

The weighted average cost of capital percentile that applies to price-quality regulation of electricity lines services and gas pipelines services has been changed from the **75th percentile** to the **67th percentile**.

This change follows the Commission's review of the appropriate weighted average cost of capital percentile for electricity lines services and gas pipeline services.

The review was initiated following the High Court's comments on the lack of sufficient evidential basis for the current weighted average cost of capital percentile (see *Wellington International Airport Ltd & Ors v Commerce Commission* [2013] NZHC [December 2013]).

Significant new analytical and empirical evidence (including market-based evidence) is now available that was not available to the Commission at the time the previous weighted average cost of capital percentile was set in December 2010, or to the Court at the time of the proceedings referred to above.

Having considered the available evidence and the submissions received on the draft input methodologies, the Commission has determined that the 67th percentile should be used for the price-quality regulation of electricity lines services and gas pipeline services. In the Commission's view, it is appropriate to use a weighted average cost of capital significantly above the mid-point estimate. This is because the potential costs of under-investment arising from a weighted average cost of capital that is too low are likely to outweigh the harm to consumers (including any over-investment) arising from a weighted average cost of capital that is too high.

The Commission considers that the evidence collected supports a weighted average cost of capital for price-quality path regulation between the 60th percentile and the 75th percentile that previously applied under the input methodologies.

The Commission's determination is that the 67th percentile estimate of the weighted average cost of capital is appropriate for price-quality regulation. In the Commission's view, a percentile around the middle of the reasonable range the Commission has defined (from the 60th to the 75th percentile) appropriately balances the relative costs to consumers of under- and over-investment, in light of the overall purpose of Part 4, which is to promote the long-term benefit of consumers of regulated services.

Notice to the Science Board—(1) In this notice, I specify under section 10(3)(b) of the Research, Science and Technology Act 2010 how much specified Research, Science and Technology funding is available, and the eligibility criteria and other requirements that must be met, for the Science Board to allocate funding for Smart Ideas in the 2015 science investment round.

(2) Smart Ideas is described in the notice entitled “Criteria for Proposals for Science-led Contestable Funding” published in the *New Zealand Gazette*, 30 October 2014, Notice No. 2014-go6681.

2. Scope—Research, Science and Technology funding is available for Smart Ideas in the 2015 science investment round from the research funds described in the notice entitled “Establishment of Innovation Board and Science Board and Other Related Notices Pursuant to the Research, Science, and Technology Act 2010” under the heading “Description of Funds within Vote RS&T”, published in the Supplement to the [New Zealand Gazette, 31 January 2011, No. 9, page 200](#), and set out below:

- a. Biological Industries;
- b. High-Value Manufacturing and Services;
- c. Energy and Minerals;
- d. Environmental;
- e. Hazards and Infrastructure; and
- f. Health and Society.

3. Eligibility—To be eligible for funding under Smart Ideas, proposals must:

- a. be to undertake research, science, or technology, or related activities that are in an area specified under the heading Nature of Fund and are in accordance with the objectives, for one or more of the research funds set out in clause 2 above;
- b. for Smart Ideas Phase 2, be based on a Smart Ideas Phase 1 contract which will expire on 30 September 2015; and
- c. meet any applicable eligibility criteria set out in the notice entitled “Criteria for Proposals for Science-led Contestable Funding” referred to in clause 1(2) above.

4. Investment Priorities—There will be no investment priorities for the allocation of Smart Ideas funding.

5. Funding Available for Smart Ideas in the 2015 Science Investment Round—(1) The indicative funding available for allocation to Smart Ideas proposals in total is \$11.5 million, excluding GST, per annum. Within this

total, or any modified total resulting from the application of clause 5.2, the Science Board may allocate funding within the following limits:

- a. for Smart Ideas Phase 1, up to \$12 million, excluding GST, per annum; and
- b. for Smart Ideas Phase 2, up to \$2 million, excluding GST, per annum.

(2) The Science Board may re-distribute available funding between Smart Ideas and Targeted Research in order to achieve a more appropriate mix of investments, as set out in the notice entitled “Criteria for Proposals for Science-led Contestable Funding” referred to in clause 1.(2) of this notice.

Criteria for Proposals for Science-led Contestable Funding

1. Notice to the Science Board—(1) In this notice, I:

- a. specify that the Science Board is to make funding decisions on proposals for science-led contestable funding under section 10(3)(b) of the Research, Science, and Technology Act 2010; and
- b. set the criteria for the assessment of proposals for science-led contestable funding under section 8(1) of the Research, Science, and Technology Act 2010.

2. General policy objective—(1) The general policy objective of science-led contestable funding is to fund research, science, or technology, or related activities that have the potential to:

- a. enhance the productivity of established industries;
- b. generate new industries for New Zealand;
- c. add new value to public services in New Zealand;
- d. develop world-leading technological capabilities by supporting programmes of research, science, or technology, or related activities to develop technology able to support a range of applications, products, and services; and
- e. give effect to the Vision Mātauranga policy.

3. Vision Mātauranga policy—(1) The Vision Mātauranga policy aims to unlock the science and innovation potential of Māori knowledge, resources and people for the benefit of New Zealand. It focuses on four themes:

- a. Indigenous innovation - contributing to economic growth through distinctive science and innovation;
- b. Taiao/Environment - achieving environmental sustainability through iwi and hapū relationships with land and sea;
- c. Hauora/Health - improving health and social wellbeing; and
- d. Mātauranga - exploring indigenous knowledge and science and innovation.

4. Science Board to make decisions on proposals for science-led contestable funding—(1) The Science Board will make funding decisions on proposals for science-led contestable funding.

(2) In making funding decisions on proposals for science-led contestable funding, the Science Board may allocate funds from the following research funds:

- a. Biological Industries
- b. High-Value Manufacturing and Services
- c. Energy and Minerals
- d. Environmental
- e. Hazards and Infrastructure
- f. Health and Society.

(3) The Science Board must make funding decisions on proposals for science-led contestable funding in

accordance with:

- a. the Public Finance Act 1989 and the relevant Appropriation Acts for Vote Science and Innovation;
- b. the criteria set out in the notice entitled “Description of Funds within Vote Research, Science and Technology” published in the Supplement to the [New Zealand Gazette, 31 January 2011, No. 9, page 200](#); and
- c. the criteria specified in this notice and the relevant schedules to this notice.

5. General eligibility criteria for science-led contestable funding proposals—(1) For a proposal to be assessed against the criteria in clause 6, the proposal must:

- a. be made by a research organisation or a New Zealand-based legal entity representing a research organisation;
- b. not be solely for the benefit of the research organisation or New Zealand-based legal entity which represents this organisation;
- c. not be made by a department of the public service as listed in Schedule 1 of the State Sector Act 1988;
- d. be for research, science, or technology, or related activities, the majority of which are to be undertaken in New Zealand, unless the Science Board considers that there are compelling reasons to consider the proposal, despite the amount of research, science, or technology, or related activities being proposed to be undertaken overseas;
- e. meet any eligibility criteria specified in the relevant schedule to this notice;
- f. meet any applicable timing, formatting, system or other similar administrative requirements imposed by the Ministry of Business, Innovation and Employment in supplying administrative services to the Science Board under section 10(7) of the Research, Science, and Technology Act 2010; and
- g. advise that the proposed funding recipient will, and the Science Board is of the view that it can, adhere to the terms and conditions of funding set out in an investment contract determined by the Science Board.

(2) For the purposes of clause 5.1(a), “research organisation” means an organisation that has internal capability for carrying out research, science or technology, or related activities.

6. Assessment criteria for science-led contestable funding proposals—(1) A proposal that has been assessed as eligible for science-led contestable funding under clause 5 must be assessed having regard to the following criteria:

- a. the criteria specified in the relevant schedule to this notice;
- b. the extent to which the proposal is likely to achieve the general policy objective of science-led contestable funding;
- c. the extent to which the proposal is likely to achieve the specific policy objectives specified in the relevant schedule to this notice;
- d. the extent to which the proposal is likely to achieve the objectives of the relevant research fund set out in the notice entitled “Description of Funds within Vote Research, Science and Technology”; and
- e. how the proposal contributes to the overall mix of investments in respect of each research fund, including the extent to which the overall mix of investments:
 - i. is likely to best achieve the objectives referred to in clause 6(b)–(d); and
 - ii. will ensure that funding is not concurrently provided in respect of any two or more programmes of research, science, or technology, or related activities that are the same or substantially similar (whether those programmes are part of a new proposal or are already being funded); and
 - iii. will minimise the risk that an applicant will not be able to undertake the relevant programme of research, science, or technology, or related activities because the applicant, or any person involved in delivering the programme, would concurrently be committed to one or more other programmes (whether those programmes are part of a new proposal or are already being funded).

7. Revocation of previous notices—I hereby revoke the notice entitled “[Criteria for Proposals for Science-led Contestable Funding](#) and [Funding for Smart Ideas in the 2014 Science Investment Round](#)” published in the Supplement to the *New Zealand Gazette*, 8 November 2013, No. 148, page 4063.

Schedule 1

Smart Ideas Investment Mechanism

1. Specific policy objectives—(1) Smart Ideas is designed to drive innovation and an entrepreneurial culture in the research community. Smart Ideas supports novel ideas and emerging capability in research, science, or technology, or related activities, which refresh the national science portfolio.

(2) Smart Ideas is intended to:

- a. support basic discovery of, or applied research into, novel, promising ideas;
- b. provide early guidance to researchers on positioning research, science, or technology, or related activities for successful application or commercialisation; and
- c. attract proposals from, and support, early career researchers in addition to more experienced researchers.

(3) Subject to clause 2.2, Smart Ideas funding is available in two phases: a research phase (“Phase 1”) and an application phase (“Phase 2”). The objectives of each phase are as follows:

- a. The objective of Phase 1 is investigative, in that it aims to use an innovative approach to develop new knowledge that will solve a problem, fulfil a need, or prove a hypothesis. While proposals should identify the potential application and benefits of the idea, the implementation pathway and user relationships should be indicative rather than detailed.
- b. The objective of Phase 2 is to encourage applicants to undertake research, science, or technology, or related activities that will help apply the idea to achieve its market potential.

2. Specific eligibility criteria—(1) To be eligible for funding under the Smart Ideas investment mechanism in either Phase 1 or Phase 2, the applicant must have committed to:

- a. receiving advice or mentoring from an entrepreneur or similar commercialisation specialist to aid commercial positioning, or from an end user or service provider who could potentially apply the results of the research, science, or technology, or related activities; and
- b. ensuring that some market or user needs analysis will be undertaken or sourced during the programme to aid its positioning.

(2) A proposal is eligible for Smart Ideas funding in Phase 2 only if the proposed research, science, or technology, or related activities directly build on the research programme that received Smart Ideas funding in Phase 1.

3. Specific assessment criteria—(1) A proposal for Smart Ideas funding that has been assessed as meeting the eligibility criteria for science-led contestable funding must be assessed against the following specific assessment criteria, and each assessment criterion must be weighted as set out below:

4. Other assessment criteria—(1) For the purposes of this notice, an “idea” is a scientific or technological hypothesis, or an approach, or a process, or a product or service in which the idea is embodied. An idea being proposed must be based on sound scientific or technological principles, and this must be substantiated in the proposal put forward.

(2) When considering the novelty of ideas under this schedule, the Science Board must consider:

- a. the novelty of the relevant idea itself rather than the novelty of the application of the idea (for example, an obvious extension of previous research, science, or technology, or related activities is not a novel idea for the purposes of this schedule);
- b. novelty globally rather than merely in relation to New Zealand;
- c. the extent to which the idea is a significant departure from previous ways of thinking and/or previous ideas, or an extension of existing or previous research which would not be obvious to a researcher who is active in the area, or a new and different combination of existing ideas; and
- d. to what extent and/or level of confidence the novelty of the idea is substantiated by its absence in existing scientific and patent literature, or elsewhere.

(3) When considering the Implementation pathway assessment criterion for both Phase 1 and Phase 2 Smart Ideas, the Science Board should apply the term “market” in the appropriate context for each research fund. For example, for research benefitting the public sector, there may only be a single or few, rather than many users making up the “market”.

(4) For each proposal the Science Board may allocate no more than \$500,000.00 (excluding GST) per year for up to two years.

Schedule 2

Enabling Technologies Investment Mechanism

1. Specific policy objectives—(1) Enabling Technologies is designed to:

- a. support the development and application of generic technologies that have the potential to be applied in a number of different ways by a number of disparate users across New Zealand’s scientific, business or other communities;
- b. accelerate the development of technology platforms that will lead to the development of the technologies described in clause 1.(1)a. of this schedule;
- c. support the technology platforms’ short-term, medium-term or long-term development needs and help them

- build a core of expertise, knowledge and relevant infrastructure;
- d. fund research, science, or technology, or related activities that are:
 - i. purpose-driven and aligned with national priorities that generate economic, environmental or social benefits for New Zealand; and
 - ii. likely to involve knowledge-transfer and co-ordination between participants linked to the proposed activities;
- e. build on New Zealand’s existing capability to undertake research, science, or technology, or related activities so there are not long start-up periods before impacts begin to accrue;
- f. support proposals that are closely aligned or partnered with users, including industry, so that pathways to development of tangible outcomes of benefit to New Zealand are incorporated from the outset;
- g. involve an integrated and multidisciplinary mix of “fit-for-purpose” research, science, or technology, and related activities that includes the expertise, capabilities and infrastructure required to deliver results (ie encompassing all stages of research from basic-targeted to applied); and
- h. support proposals that include, if appropriate, strong international links so there is both rapid absorption of relevant and applicable overseas knowledge and expansion of New Zealand’s market potential, while ensuring appropriate safeguards for New Zealand’s intellectual property.

(2) For the purposes of this schedule, a “technology platform” is a critical mass of capabilities and equipment that is responsive to industry needs and that provides the means to enhance the performance and capabilities of the users.

2. Specific assessment criteria—A proposal for Enabling Technologies funding that has been assessed as meeting the eligibility criteria for science-led contestable funding must be assessed against the following specific assessment criteria, which are all weighted equally:

Specific policy objectives—(1) Targeted Research is designed to support purpose-driven research, science, or technology, and related activities aligned with national priorities that generate economic, environmental or social benefits for New Zealand. To increase the impact of the national science portfolio, knowledge transfer is an important part of such programmes of research, science, or technology, or related activities.

(2) Targeted Research addresses New Zealand’s strategic needs, challenges and opportunities.

2. Specific assessment criteria—A proposal for Targeted Research funding that has been assessed as meeting the eligibility criteria for Science-led contestable funding must be assessed against the following specific assessment criteria, which are all weighted equally:

Student Allowance Transfer Grant Amendment 2014

Pursuant to section 124(1)(d) of the Social Security Act 1964, the Minister for Social Development makes the following instrument.

Instrument

1 Title—This instrument is the Student Allowance Transfer Grant Amendment 2014.

2 Commencement—This instrument comes into force on the day after it is made.

3 Principal programme—This instrument amends the Student Allowance Transfer Grant Programme (as established and approved on 23 July 2002 February 1999)¹ (the principal programme).

4 Clause 4 amended (Interpretation)—In clause 4(1), insert in their appropriate alphabetical order:

“**full-time course** has the same meaning as in the Regulations

full-time student—

- a. has the same meaning as in section 3(1) of the Act; and
- b. includes a person who, during the period between the end of the portion of a full-time course during a calendar year and the start of the next portion during that same year, was enrolled in that portion of that course and who intends to continue study in the next portion of that course; and
- c. also includes a person who, during the period between the end of a portion of a full-time course during a calendar year (**portion A**) and the start of a portion of a full-time course during that same year (**portion B**), was enrolled in portion A and who intends to enrol in portion B”.

5 Clause 6 amended (Transfer grants)—(1) In clause 6.1(e), replace “5 working days” with “28 days”.

(2) In clause 6, after subclause (1), insert:

“(1A) Subclause (2) also applies to an applicant for a working-age benefit to whom subclause (1)(b) and (c) apply and who—

- a. is a full-time student; and
- b. applies for the working-age benefit to support himself or herself during the period between—
 - i. the end of an academic year and the start of the next; or
 - ii. the end of a portion of a full-time course and the start of a portion of that course or another full-time course during the same calendar year; and
- c. is applying for the working-age benefit because he or she will cease to receive the student allowance by reason of the end of the academic year or portion of the full-time course, as the case may be; and
- d. applies for a transfer grant before or within 28 days after the specified period ends.”

Explanatory Note

This note is not part of the instrument, but is intended to indicate its general effect.

This instrument, which comes into effect on the day after it is made, amends the Student Allowance Transfer Grant Programme under the Social Security Act 1964 to make it easier for sole parents to receive the grant when they apply for a working-age benefit to support themselves during academic breaks. The amendment extends the period during which applications for the grant can be considered from five working days after their student allowances stops to 28 days.
