futures adviser service means a service provided by or on behalf of the company in relation to a specified futures contract that would, but for section 14(1)(n) of the Financial Advisers Act 2008, constitute financial advice or a discretionary investment management service under that Act

personalised futures adviser service means a futures adviser service that would, but for section 14(1)(n) of the Financial Advisers Act 2008, constitute a personalised service under that Act

product disclosure statement means a document:

- $a. \ that \ describes \ and \ contains \ the \ offer \ of, \ and \ relates \ specifically \ to, \ the \ specified \ futures \ contracts;$
- b. that is identical to a document that is:
 - i. a product disclosure statement in terms of the Corporations Act 2001; and
 - ii. signed by the persons (if any) who are required by law to sign that document; and
- c. that is not an "offer information statement" or "profile statement" (as those terms are defined in section 9 of the Corporations Act 2001)

Regulations means the Futures Industry (Client Funds) Regulations 1990

specified futures contract means a futures contract that is issued by the company and described in the product disclosure statement.

(2) Any term or expression that is defined in the Act or the Regulations and used, but not defined, in this notice has the same meaning as in the Act or the Regulations.

- **3 Authorisation**—(1) The company is authorised to carry on the business of dealing in specified futures contracts to which the company is, or intends to be, a party.
- (2) The authorisation in this clause 3 is subject to the conditions that:
 - a. the company does not enter into specified futures contracts with any person other than a person who has entered into a written agreement with the company, and then only in accordance with the terms of that agreement;
 - b. the company is licensed as an Australian Financial Services Licensee under the Corporations Act 2001 and holds an AFS Licence that authorises the company to advise retail and wholesale clients on, and to deal with retail and wholesale clients in, specified futures contracts;
 - c. the company notifies the FMA if the company's AFS Licence is varied or revoked and notifies the FMA of any regulatory action taken by ASIC in relation to its AFS Licence;
 - d. there is a product disclosure statement relating to the specified futures contracts at the time that the specified futures contracts are made available to New Zealand investors or the company gives advice or assistance to, or induces or attempts to induce, New Zealand investors in relation to the acquisition or disposal of any specified futures contracts;
 - e. before the company enters into a specified futures contract with any person, that person has received copies of the following:
 - $i.\ a\ product\ disclosure\ statement\ relating\ to\ that\ specified\ futures\ contract;$ and
 - ii. every supplementary product disclosure statement relating to that specified futures contract in use at the time of the entry by the company into the specified futures contract;
 - f. the company must hold client funds in a segregated client funds account as if the funds were subject to the provisions of its AFS Licence, the Corporations Act 2001 and any regulations made under the Corporations Act 2001 in relation to the protection of client money and client property;
 - g. the company maintains proper records:
 - i. to record dealings in respect of specified futures contracts with clients;
 - ii. to record client money, funds and property held or received in connection with dealings in specified futures contracts; and
 - iii. that are audited or reviewed, and reported on, in accordance with the company's AFS Licence;
 - h. the company provides the FMA with a copy of the company's audited financial statements no later than three months after the end of each of its financial years;
 - i. before the company provides any personalised futures adviser service to any retail client in relation to a specified futures contract, the company has provided that person with an adviser disclosure statement which clearly sets out the following information:
 - i. the name and contact details of the company;
 - ii. a statement to the effect that that advice on futures contracts is regulated under the company's authorisation as a futures dealer and is not regulated under the Financial Advisers Act 2008;
 - iii. the types of products the company deals in and, if advice on any product is only provided by some advisers, which advisers can provide advice on each product;
 - iv. a description of how the company and its advisers are remunerated for futures dealing services;
 - v. a description of any other factors which may materially influence the advice given by the company or its advisers;
 - vi. details of any bankruptcy or insolvency event occurring in the past five years in respect of the company or one of its advisers;
 - vii. details of any disciplinary or criminal proceedings resulting in an adverse finding in the past five years in respect of the company or one of its advisers;
 - viii. details of any conviction for an offence of dishonesty against any of the company's advisers;
 - ix. a description of the internal and external dispute resolution schemes available to the client, and an explanation of how to make a complaint; and
 - x. a description of the FMA's role in authorising futures dealers, and details of how to contact the

FMA;

- j. the company takes reasonable steps to ensure at all times that each adviser who provides futures adviser services to a client:
 - i. exercises the care, diligence and skill that a reasonable adviser would exercise in the same circumstances:
 - ii. has the competence, knowledge and skills to provide futures adviser services to that client, and in respect of the relevant specified futures contract;
 - iii. places the interests of the client first, and acts with integrity, in providing the futures adviser services:
 - iv. ensures that the client has sufficient information, in a form which enables the client to understand that information, to make an informed decision about the futures adviser service and the specified futures contracts to which that futures adviser service relates;
 - v. ensures that the client understands whether or not any advice given takes into account the personal circumstances of the client; and
 - vi. does not act in any way, or make any omission, which would bring the financial services profession, or any part of it, into disrepute;
- k. the company maintains professional indemnity insurance for its business at all times to the level required by its AFS Licence;
- l. the company maintains at all times an external dispute resolution scheme that is available to its New Zealand clients who are members of the public;
- m. any company document that states the company has been authorised by the FMA to carry on the business of dealing in futures contracts includes a statement to the effect that:
 - i. the FMA's role in authorising futures dealers is limited and does not imply approval or endorsement of the business, trading or solvency of the company; and
 - ii. the FMA has not approved any agreements or any disclosure documents of the company;
- n. the company immediately notifies the FMA in writing of any of the following events:
 - i. the insolvency of the company or the bankruptcy of any of its directors or senior management;
 - ii. if the company, or any of its directors or senior management, is convicted of an indictable offence;
 - iii. where a receiver, provisional liquidator, liquidator or a similar officer is appointed, or any resolution is passed or order made for the winding up or dissolution of the company;
 - iv. any regulatory action taken against it, or any of the company's directors or senior management, whether in New Zealand or elsewhere;
 - v. if any director or senior manager leaves the company or if any new director or member of senior management is appointed to the company; and
 - vi. if any auditor's report prepared in accordance with the company's AFS Licence shows any non-compliance with that AFS Licence or the Corporations Act 2001; and
- o. the product disclosure statement for the specified futures contracts to be entered into by the company is accompanied by statements or information to the following effect under the heading "Important Information for New Zealand Investors":
 - i. the name and address of the company (unless the information is provided in the product disclosure statement);
 - ii. that the company may not be subject in all respects to New Zealand law;
 - iii. information describing how returns to New Zealand investors are likely to be affected by New Zealand taxation rules and how, as a result, any returns to New Zealand investors may differ from the returns for Australian investors described in the product disclosure statement;
 - iv. that, despite the information provided under paragraph iii., investors should satisfy themselves as to the tax implications of entering into the specified futures contracts;
 - v. that entry into the specified futures contracts may carry with it a currency exchange risk;
 - vi. that the financial reporting requirements applying in New Zealand and those applying in respect of

the company may be different, and the financial statements of the company may not be compatible in all respects with financial statements prepared in accordance with New Zealand law;

- vii. information or statements to the following effect under the heading "Agreement as to Jurisdiction":
 - A. that, in respect of a dispute concerning the specified futures contracts, the company:
 - 1. agrees to submit to the non-exclusive jurisdiction of the New Zealand courts;
 - 2. has instructed the New Zealand agent for service referred to in subparagraph C. to accept service on the company's behalf;
 - 3. agrees that this statement is an agreement with each investor for the purposes of section 389(1)(e) of the Companies Act 1993; and
 - B. that, despite the statements referred to in subparagraph A., the specified futures contracts may not always be enforceable in New Zealand courts; and
 - C. the name and contact address of the person in New Zealand who has been appointed by the company to accept service in New Zealand of any document on its behalf; and
- p. at the same time as the specified futures contracts are made available by the company to New Zealand investors in reliance on the authorisation in this notice, those specified futures contracts are also made available to Australian investors in accordance with the laws of Australia.

Notification of Amendments to Input Methodologies Applicable to Electricity Distribution Businesses, Gas Pipeline Businesses and Airports

The input methodologies applicable to electricity distribution businesses, gas pipeline businesses and airports under Part 4 of the Act have been amended by the High Court under section 52Z(3)(b)(i) of the Act.

The amendments relate to the following determinations:

- Electricity Distribution Services Input Methodologies Determination 2012, [2012] NZCC 26 (the "EDB IM Determination"):
- Gas Distribution Services Input Methodologies Determination 2012, [2012] NZCC 27 (the "GDB IM Determination");
- Gas Transmission Services Input Methodologies Determination 2012, [2012] NZCC 28 (the "GTB IM Determination"); and
- Commerce Act (Specified Airport Services Input Methodologies) Determination 2010 (Commerce Commission Decision No. 709, 22 December 2010) (the "Airport IM Determination").

The amendments are set out in the *Publication of Electricity, Gas, and Airport Input Methodology Amendments order by the High Court* ("Amendment").

The Amendment amends the input methodologies for reconsideration of default price-quality paths set out in Subpart 5 of Part 4 of the EDB IM determination the GDB IM Determination, and the GTB IM Determination.

The Amendment also amends the input methodologies contained in the Airport IM Determination for:

- i. the initial valuation date for land; and
- ii. Auckland International Airport Limited's cost of constructing the Northern Runway.

This amendment gives effect to the High Court decision in Wellington International Airports Ltd and others v Commerce Commission [2013] NZHC 3289.

Notification of Amendments to Input Methodologies Applicable to Electricity Distribution Businesses

Pursuant to section 52W of the Commerce Act 1986 (the "Act"), the Commerce Commission ("Commission") gives the following notice.

The Commission has amended the input methodologies applicable to electricity distribution businesses contained in the *Electricity Distribution Services Input Methodologies Determination 2012* [2012] NZCC 26.

The amendments are set out in the *Electricity Distribution Input Methodology Amendments Determination 2014* [2014] NZCC 31 ("Amendment").

The Amendment comes into effect on the date of this notice.

The Amendment amends the input methodologies that apply to default and customised price-quality paths for electricity distribution businesses from 1 April 2015.

The Amendment relates to corrections to terms the Commission uses to set starting prices based on the current and project profitability of each electricity distribution business ("first type amendments") and changes that affect other aspects of the default price-quality path ("second type amendments").

The first type amendments:

- i. reflect a mid-year cash-flow timing assumption in the relevant definitions of notional deductible interest for the treatment of taxation;
- ii. correct for the double deduction of the term credit spread differential allowance when calculating the regulatory tax allowance; and
- iii. correct the definition of amortisation of initial differences in asset values to take account of the changes in initial difference values that result from the age, sale and acquisition of relevant assets.

The second type amendments are primarily focused on pass-through and recoverable costs, and their treatment under the weighted average price cap. The Amendment limits the risk of under- and over-recovery of pass-through and recoverable costs.

In addition, the second type amendments make a number of changes in relation to recoverable costs, including to:

- i. give effect to the quality incentive scheme the Commission will implement under section 53M(2) of the Act;
- ii. give effect to incentives for each electricity distribution business to undertake energy efficiency and demand side management initiatives;
- iii. provide a "wash-up" for forecast capital expenditure in the years prior to the setting of a default price-quality path determination;
- iv. provide a "wash-up" for additional expenditure related to transmission asset purchases in a regulatory period for transmission asset purchases that were forecast to be completed prior to a price reset, but which were not concluded;
- v. provide for the recovery of prudent expenditure incurred because of a catastrophic event following reconsideration of a default price-quality path;
- vi. allow for the recovery of amounts relating to other reconsideration events, following a reconsideration of a default price-quality path or customised price-quality path, other than from a catastrophic event;
- vii. allow for recovery of levies or other charges or costs associated with the extended reserves regime administered by the Electricity Authority;
- viii. update the recoverable cost term for avoided transmission costs for distributed generation; and
- ix. allow for the one-off recovery of additional revenue for three electricity distribution business arising from the 2012 reset of the default price-quality path applicable to electricity distribution businesses.

The reason for the changes to the specification of price input methodologies introduced by the second type

amendments is to limit the risk of under- or over-recovery of pass-through and recoverable costs.

The second type amendments also introduce several new recoverable costs that provide a number of incremental improvements.

The new recoverable costs:

- i. include new incentive schemes intended to provide incentives for suppliers to maintain or improve their quality of supply, and to improve energy efficiency and demand-side management, including improving incentives to invest in new assets with an energy efficiency and demand-side management purpose;
- ii. allow the Commission to provide an adequate response to a reconsideration event (such as a catastrophic event) for electricity distribution businesses and consumers; and
- iii. allow the Commission to take into account developments being undertaken by the Electricity Authority that may impact certain recoverable costs.

- Transpower Input Methodologies Determination [2012] NZCC 17

The input methodologies which are amended are contained in the *Incremental Rolling Incentive Scheme Input Methodology Amendments Determination 2014* [2014] NZCC 32 ("Amendment").

The Amendment comes into effect on the date of this notice.

The Amendment introduces a new form of Incremental Rolling Incentive Scheme (IRIS) to apply to future individual and default price-quality path determinations. The IRIS provides a mechanism by which suppliers that are subject to price-quality regulation can retain the benefits of efficiency gains beyond the end of a regulatory period.

The IRIS applicable to non-exempt electricity distribution businesses:

- i. affects incentives for default price-quality paths;
- $ii.\ can\ be\ described\ as\ "symmetric";$
- iii. provides incentives that are the same in each year of the regulatory period; and
- iv. affects incentives to control operating and capital expenditure during a regulatory control period.

The IRIS applicable to Transpower:

- i. can be described as "symmetric";
- ii. provides incentives that are the same in each year of the regulatory period; and
- iii. affects incentives to control operating expenditure during a regulatory control period.

The Commission has amended these input methodologies to improve the incentives for electricity distribution businesses and Transpower to control expenditure and to improve efficiency, and share improvements in efficiency with consumers through prices that are lower than they otherwise would have been.

Notification of Amendment to Input Methodologies for Transpower to Introduce a Listed Project Mechanism

The Commerce Commission ("Commission") has amended the input methodologies applicable to electricity lines services supplied by Transpower New Zealand Limited ("Transpower") under Part 4 of the Commerce Act 1986.

The amended input methodologies are:

- Transpower Input Methodologies Determination [2012] NZCC 17; and
- Transpower Capital Expenditure Input Methodology Determination [2012] NZCC 2

The amendment is set out in the *Transpower Input Methodologies Amendment Determination 2014 (No. 2)* [2014] NZCC 34.

The Commission has created a "listed project" mechanism which allows Transpower to apply, within a regulatory period, for approval of additional capital expenditure ("capex") relating to pre-identified large (ie forecast to cost more than \$20 million) asset refurbishment or asset replacement projects. These projects should have at least one (or more) assets likely to be commissioned in the regulatory period, and must be projects for which a commencement date within the regulatory period is anticipated but cannot be forecast with specificity.

Reasons

The Commission has made this amendment so that, for listed large asset replacement and asset refurbishment projects, Transpower has increased timing flexibility to apply (within a regulatory period) for additional capex associated with those projects.

Transpower has previously indicated its view that large projects with high cost or timing uncertainty (such as large reconductoring projects) are a poor fit with the base capex framework. In the absence of a listed project mechanism, these projects would fall within the broader base capex portfolio, for which the Commission must set a base capex allowance in advance of each regulatory period. The processes contained within the *Transpower Capital Expenditure Input Methodology Determination* require Transpower to submit a base capex proposal 16 months prior to a regulatory period.

The listed project mechanism allows listed large asset replacement and asset refurbishment projects that are subject to uncertain timing to be separated from the base capex proposal and submitted for approval of additional capex within a regulatory period. Additional time allows Transpower to undertake more investigation, planning, and detailed design work so that a listed project commencement date can be predicted with more certainty, and more accurate cost estimation for that project is likely.

In the Commission's view, once capex relating to a listed project is approved, further timing or cost estimation uncertainty can be accommodated within the base capex framework, noting the fungible nature of the base capex portfolio permits substitution by Transpower between projects and programmes.

Summary

The mechanism requires listed projects to meet certain requirements before the Commission can, at its discretion and before the start of a regulatory period, identify them as such in an individual price-quality path determination. Once listed, Transpower can apply to the Commission for approval of additional capex relating to a listed project.

When seeking approval of additional capex relating to a listed project, Transpower must meet certain requirements. These include specific information requirements, and a requirement for Transpower to consult (prior to seeking approval) with interested persons in accordance with Transpower's own policies and processes, and at a scope commensurate with the project's nature, complexity, impact and significance.

The processes for evaluating an application for approval of additional capex relating to a listed project are commensurate with those that would apply if the listed project was an identified programme submitted as part of Transpower's base capex proposal prior to the regulatory period.

The criteria the Commission will use to evaluate an application for approval of additional capex relating to a listed project are the same as those which would apply if the listed project was an identified programme submitted as

part of Transpower's base capex proposal prior to the regulatory period.

The Commission will make and publish its decision on any application by Transpower for approval of additional capex relating to a listed project as soon as reasonably practicable.

The Commission will then take account of the revenue impact of any capex approved by the Commission for a listed project within a regulatory period when it reconsiders Transpower's individual price-quality path, in each year (save the last), of that regulatory period.

Additional capex relating to a listed project that is approved by the Commission will be able to be substituted by Transpower between base capex projects within the overall envelope of approved base capex for the regulatory period, and subject to the base capex incentive framework in the *Transpower Capital Expenditure Input Methodology Determination*.
