

 - "call deposit" means a deposit (not being an agency deposit, an investment deposit, a protection deposit, a special deposit or a trust deposit) held in the ordinary course of administration, and determined by Public Trust to be held at call;
 - "deposit" means a sum of money held by Public Trust belonging to any estate, which money for the time being forms part of the Common Fund;
 - "investment deposit" means a deposit held at call or otherwise as an investment under section 51 of the Act;
 - "protection deposit" means a deposit, held at call, of tuition, boarding, accommodation or other fees by or on behalf of a student enrolled at a Private Training Establishment within the meaning of Part 18 of the Education Act 1989;
 - "special deposit" means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;
 - "trust deposit" means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:
 - (i) for persons not of full age or capacity; or
 - (ii) for beneficiaries not entitled to payment at call; or
 - (iii) otherwise than at call.
- (2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.
- **3. Rates of Common Fund interest**—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.

Ministerial Exemptions Under the Anti-Money Laundering and Countering Financing of Terrorism Act 2009

In accordance with section 157(6)(b) of the Anti-Money Laundering and Countering Financing of Terrorism Act 2009 ("the Act"), the Associate Minister of Justice hereby gives notice that he has granted the following exemptions from the Act:

Ministerial Exemption: Trustees of the Glaxo New Zealand Pension Plan

- 1. In my capacity as the Associate Minister of Justice and pursuant to section 157 of the Anti-Money Laundering and Countering Financing of Terrorism Act 2009 ("the Act"), I exempt the trustees of the Glaxo New Zealand Pension Plan ("Plan") from the provisions of Part 2 of the Act in relation to services provided as trustees of the Plan.
- 2. This exemption is subject to the following conditions:
 - a. The Plan must remain a registered superannuation scheme as defined under the Superannuation Schemes Act 1989 or registered under the Financial Markets Conduct Act 2013, as applicable.
 - b. The payment arrangement, where the Plan receives payments from the participating company, Tower and one pensioner (whose contribution is insufficient to meet the cost of his Southern Cross premium) and makes payments of the same amount to certain pensioners and Southern Cross, can only be provided to the Plan's current 19 members.
 - c. With the exception of Australian superannuation transfers to the Scheme (if applicable), customer due diligence in accordance with sections 10-36 of the Act and suspicious transaction reports in accordance with sections 40-48 of the Act and, where the transaction is relevant to a suspicious transaction report, transaction records in accordance with sections 49(1) and (2)(a)-(f) of the Act are required on all contributions and transfers to the Plan from international sources.
- 3. The exemption has been granted for the following reasons:
 - a. The Plan poses a very low risk of money laundering or terrorist financing;
 - b. the payments made under the payment arrangement that are not provided for in the trust deed of the Plan are small in quantum, historical in nature and the amounts payable are non-discretionary;
 - c. the Plan has not admitted new members since 1996 and only has 19 members, all of whom are retired and in receipt of a pension from the Plan;
 - d. due to the very low money laundering and terrorist financing risks raised by the Plan and the significant compliance costs that would arise from not granting this exemption, I consider that any benefits of requiring compliance with the Act are not justified by the associated costs; and
 - e. this exemption is consistent with (and has no effect on the purpose or intent of) the Act, the Financial Transactions Reporting Act 1996 and New Zealand's international obligations as a member of the Financial Action Task Force and the Asia Pacific Group on Money Laundering.
- 4. This exemption came into force on the day after the date I granted this exemption (21 June 2015).
- 5. This exemption will expire on 30 June 2018.

Ministerial Exemption: epay New Zealand Limited

- 1. In my capacity as the Associate Minister of Justice and pursuant to section 157 of the Anti-Money Laundering and Countering Financing of Terrorism Act 2009 ("the Act"), I exempt epay New Zealand Limited ("epay") from all provisions of the Act in relation to services it provides to enable customers to pay their electricity bills.
- 2. The exemption is granted subject to the following conditions:
 - a. Every wire transfer must relate only to the payment of electricity bills directly to the bank account or facility of an "industry participant" as defined under section 7(1) of the Electricity Industry Act 2010.
 - b. Every wire transfer undertaken as part of the exempted service must be domestic in nature, as defined under section 27(7) of the Act.
 - c. Wire transfers undertaken as part of the exempted service must not exceed \$1000.00.
 - d. Bill payment reports are to be held and maintained by epay for a period of five years in accordance with sections 49(1) and 49(3) of the Act.
- 3. The exemption has been granted for the following reasons:
 - a. The narrow scope of services offered by epay to customers;
 - b. the lack of contact between epay and customers;
 - c. the low value of payments made; and
 - d. the process-driven systems employed to transfer payment from the payer to the payee.
- 4. The granting of this exemption is not inconsistent with the purpose or intent of the Act or the Financial Transactions Reporting Act 1996 or New Zealand's international obligations as a member of the Financial Action Taskforce and the Asia Pacific Group on Money Laundering.
- 5. This exemption came into force on the day after the date I granted this exemption (21 June 2015).
- 6. This exemption will expire on **30 June 2018**.

Notice of Replacement by the Nursing Council of New Zealand of the Scope of Practice and the Prescribed Qualifications for Registered Nurses

Commencement

This notice is given pursuant to sections 11(1) and 12(1) of the Health Practitioners Competence Assurance Act 2003 ("the Act") and comes into effect on **9 July 2015**.

On that date it replaces the Notice of Replacement Scope of Practice and Qualifications Prescribed by the Nursing Council of New Zealand for Registered Nurses published in the <u>New Zealand Gazette</u>, 26 August 2010, No. 108, page 2916, which came into force on 30 September 2010, and the Notice of Replacement Qualifications Prescribed by the Nursing Council of New Zealand for Registered Nurses from Overseas published in the <u>New Zealand Gazette</u>, 24 January 2013, No. 5, page 286, which came into force on 1 March 2013.

Explanatory Note

Introduction

Under sections 11(2) and 12 of the Health Practitioners Competence Assurance Act 2003, the Nursing Council of New Zealand ("the Council") is required to describe the scope of practice for nursing in New Zealand and prescribe the qualifications required for each scope of practice.

Changes coming into effect on 9 July 2015

In July 2014, the Nursing Council consulted on possible changes to the prescribed qualifications for the registered nurse scope of practice to include a pre-registration master's degree. A pre-registration master's degree in

nursing would offer an additional pathway for entry into nursing for candidates already holding a bachelor's degree in another discipline. This pathway is already available in other countries.

The Council sought the views of stakeholders in aged care, allied professional organisations, consumer groups, district health boards, educational institutions, government agencies, health and homecare agencies, international nursing regulatory authorities, professional organisations representing nurses, Māori advisors and nurse executives. The consultation document was also available on the Council website for public comment.

77 submissions were received with submitters divided on support for the proposal. In February 2015, after considering the consultation feedback, the Council agreed to amend the prescribed qualifications to allow graduate (Level 7, New Zealand Qualification Framework (NZQF)) or postgraduate (Level 8, NZQF) nursing qualifications that meet the Council's *Education programme standards for the registered nurse scope of practice* to lead to registration in the registered nurse scope of practice. This amendment was in response to some submissions requesting a broader range of graduate and postgraduate qualifications leading to registration in the registered nurse scope of practice.

In prescribing qualifications under section 12 the Council must be guided by the following principles set out in section 13 of the Act:

- a. The qualifications must be necessary to protect members of the public; and
- b. the qualifications may not unnecessarily restrict the registration of persons as health practitioners; and
- c. the qualification may not impose undue costs on health practitioners or on the public.

The Council's decision was that graduate (Level 7, NZQF) or postgraduate (Level 8, NZQF) nursing qualifications will offer a shortened pathway to registration for graduates. However, the Council requires such programmes to meet the same *Education programme standards for the registered nurse scope of practice*, including programme content, clinical experience and demonstrating competence and fitness for registration. These requirements would ensure that programme graduates demonstrated safe and competent practice on completion of a pre-registration nursing qualification.

The amendment therefore adheres to the principles that the qualification is necessary to protect members of the public and will not restrict the registration of persons as registered nurses.

Previous notices

The Council last published the scope of practice for New Zealand and Overseas Registered Nurses in September 2010, the prescribed qualifications for New Zealand Registered nurses in September 2010 and the prescribed qualifications for Overseas Registered Nurses in March 2013.

Scope of Practice—Registered Nurses

Registered nurses utilise nursing knowledge and complex nursing judgment to assess health needs and provide care, and to advise and support people to manage their health. They practise independently and in collaboration with other health professionals, perform general nursing functions, and delegate to and direct enrolled nurses, health care assistants and others. They provide comprehensive assessments to develop, implement, and evaluate an integrated plan of health care, and provide interventions that require substantial scientific and professional knowledge, skills and clinical decision making. This occurs in a range of settings in partnership with individuals, families, whānau and communities. Registered nurses may practise in a variety of clinical contexts depending on their educational preparation and practice experience. Registered nurses may also use this expertise to manage, teach, evaluate and research nursing practice. Registered nurses are accountable for ensuring all health services they provide are consistent with their education and assessed competence, meet legislative requirements and are supported by appropriate standards. There will be conditions placed in the scope of practice of some registered nurses according to their qualifications or experience limiting them to a specific area of practice.

The Nursing Council competencies for Registered Nurses describe the skills and activities of registered nurses.

Prescribed Oualifications

New Zealand Graduates

- a. A bachelor's degree in nursing approved by the Nursing Council of New Zealand; or
- b. a graduate nursing qualification at Level 7 on the New Zealand Qualifications Framework approved by the Nursing Council of New Zealand; or
- c. a postgraduate nursing qualification at Level 8 on the New Zealand Qualifications Framework approved by

the Nursing Council of New Zealand; and

- d. a pass in an assessment of Nursing Council Competencies for Registered Nurses by an approved provider; and
- e. a pass in an Examination for Registered Nurses set by the Nursing Council of New Zealand.

Registered Nurses from Overseas

- a. Current registration with an overseas regulatory authority; and
- b. successful completion of a nursing programme that is, in the Nursing Council's opinion, equivalent to or as satisfactory as a bachelor's degree programme in nursing at Level 7 on the New Zealand Qualifications Framework; or
- c. successful completion of a graduate pre-registration nursing programme that is, in the Nursing Council's opinion, equivalent to or as satisfactory as an approved New Zealand graduate nursing programme at Level 7 on the New Zealand Qualifications Framework that leads to registration in the registered nurse scope of practice; or
- d. successful completion of a postgraduate pre-registration nursing programme that is, in the Nursing Council's opinion, equivalent to or as satisfactory as an approved New Zealand postgraduate nursing programme at Level 8 on the New Zealand Qualifications Framework that leads to registration in the registered nurse scope of practice; and
- e. two years' post-registration nursing practice as a registered nurse of at least 2,500 hours within the five years immediately preceding the date of the application; and
- f. at the direction of the Nursing Council, successful completion of a Nursing Council approved competence assessment programme.
