# **Auckland Bus Stops Trial**

Pursuant to subclause 3.4(1) of Land Transport Rule: Traffic Control Devices 2004 ("the Rule") and a delegation from the NZ Transport Agency, I, Glenn Bunting, Network Manager, authorise the installation and maintenance of bus stops with a yellow box marking and a single sign:

- a. for the purpose described in Schedule 1;
- b. in the form and layout set out in Schedule 2;
- c. at the location stated in Schedule 3;
- d. for the period specified in Schedule 4; and
- e. subject to the evaluation outlined in Schedule 5.

A reduction in the number of traffic control device elements needed to indicate bus stops may be installed for the purpose of evaluating the use of this combination and the trial will be called the "Auckland bus stops trial".

#### Schedule 1-Purpose of trial

The purpose of the trial is to:

- a. evaluate the effectiveness and safety of bus stops that are identified with fewer signs and markings than are currently required (ie with only one sign, as an alternative to the requirement in subclause 12.5(1), and without the "BUS STOP" marking referred to in subclause 12.4(5A) and specified in diagram M3-2 or M3-2A in Schedule 2 of the Rule); and
- b. assess drivers' understanding of different combinations of traffic control devices to mark the location of bus stops.

#### Schedule 2-Form and layout of bus stops for the trial

For the purpose of the trial bus stops of no more than 30 metres in length may be identified as follows:

- a. The area of the bus stop must be marked with:
  - i. a continuous yellow line at right angles to the kerb or roadway edge at each end of the bus stop; and
  - ii. a broken or continuous yellow line parallel to the kerb or roadway edge, not less than two metres and

not more than three metres from the kerb or roadway edge; and

b. a bus stop sign that complies with Schedule 1 of the Rule must be erected within the area of the bus stop and close to the end of the area furthest from an approaching driver.

### **Schedule 3-Location**

The location approved for this trial is at bus stops of no more than 30 metres in length in the Auckland region under the management or control of Auckland Transport.

#### Schedule 4-Period of trial

The trial may begin after the publication of this notice and, unless terminated earlier, must end by 30 November 2016.

#### Schedule 5-Evaluation

An evaluation must be undertaken and a report prepared which includes discussion and analysis of the following:

- a. an assessment of the comparative level of parking infringements issued at various similar bus stop sites identified by current Rule requirements and sites identified in accordance with Schedule 2 of this notice;
- b. an assessment of the comparative level of challenges arising from parking enforcement at various similar sites identified in accordance with current Rule requirements and sites identified in accordance with Schedule 2 of this notice; and
- c. an assessment of drivers' understanding of the methods used to indicate bus stops both the current Rule requirements and those in accordance with Schedule 2 of this notice.

An interim evaluation report must be sent to me by 31 May 2016 and a final report by 31 March 2017.

# Direction to the Earthquake Commission Pursuant to Section 112 of the Crown Entities Act 2004

- 1. This direction comes into effect immediately upon signing and applies from September 2010.
- 2. The Earthquake Commission ("Commission") shall perform the following additional function: Subject to paragraph 3, pay the amount of the damage to, or replace or reinstate (at the Commission's option), any residential land or any part of it that suffered natural disaster damage:
  - a. of which no notice has been given by the insured person in accordance with clause 7(1) of Schedule 3 of the Earthquake Commission Act 1993 ("EQC Act"), and
  - b. which has been apportioned by the Commission to one of the Canterbury earthquakes ("first-mentioned Canterbury earthquake") where the insured person has notified (in accordance with clause 7(1) of Schedule 3 of the EQC Act) natural disaster damage to that residential land or part of it caused or claimed to have been caused by another Canterbury earthquake.
- 3. The Commission's obligation to pay the amount of the damage, or to replace or reinstate (at the Commission's option), under paragraph 2 shall not exceed the extent of the requirement to pay the amount of the damage, or to replace or reinstate, that would otherwise apply should:
  - a. the insured person have given notice in accordance with clause 7(1) of Schedule 3 of the EQC Act, and
  - b. the Commission (in accordance with the EQC Act) have paid the amount of the damage to or, as the case may be, opted to replace or reinstate the residential land or part of it that suffered the natural disaster damage which was apportioned by the Commission to the first-mentioned Canterbury earthquake.
- 4. For these purposes:
  - 1. insured person, natural disaster damage, personal property, residential building and residential land have the meanings given those terms in the EQC Act;

- 2. **Canterbury earthquakes** has the meaning given that term in the Canterbury Earthquake Recovery Act 2011;
- 3. for the avoidance of doubt, the insured person has given notice in accordance with clause 7(1) Schedule 3 of the EQC Act of natural disaster damage to the residential land or any part of it if the insured person has given notice of any natural disaster damage to any of the insured property caused by the same Canterbury earthquake; and

# 4. insured property means:

- i. the residential land;
- ii. a residential building situated on that residential land;
- iii. any personal property located in or on that residential building; and
- iv. any part of any of the property in i-iii.
