#### Variable Speed Limits—State Highway 1 and State Highway 2, Wellington

Pursuant to clause 6.1 of the Land Transport Rule: Setting of Speed Limits 2003 and a delegation from the NZ Transport Agency, I, Glenn Bunting, Network Manager, approve variable speed limits on State Highway 1 and State Highway 2 at Wellington in accordance with the conditions set out in this notice.

##### Conditions

##### 1. Variable Speed Limit

The NZ Transport Agency (Highways and Network Operations Group) may set a variable speed limit of 30, 40, 50,

60, 70, 80 or 100km/h on the sections of State highway specified in Condition 2 of this notice. The speed limit may be varied to manage the safe flow of traffic:

- a. according to the numbers and types of road users;
- b. for changing traffic volumes, including to ease congestion;
- c. for emergency or temporary traffic management; or
- d. in accordance with environmental conditions.

## 2. Sections of State Highway

Variable speed limits may be set for the following sections of State highway:

- a. State Highway 1 at Wellington, from the Paremata roundabout to the intersection of State Highway 1 and Willis Street, including all on-ramps and off-ramps connected to this section of State highway; and
- b. State Highway 2 at Wellington, from the intersection of State Highway 2 and Melling Link to the southern end of State Highway 2 at the Ngauranga Interchange, including all on-ramps and off-ramps connected to this section of State highway.

## 3. Signs

Speed limit signs that comply with the Land Transport Rule: Traffic Control Devices 2004 must be installed to identify a length of road subject to a variable speed limit as follows:

- a. except where Condition 3(b) applies, at least two “Variable speed” (R1-2.1) signs at the beginning of a length of road to which a variable speed limit applies, facing road users travelling towards the variable speed limit;
- b. on single lane on-ramps, at least one “Variable speed” (R1-2.1) sign at the beginning of the length of road to which a variable speed limit applies, facing road users travelling towards the variable speed limit;
- c. at least two “Variable speed” (R1-2.1) repeater signs installed at each location with a spacing of no more than 1.5km between variable speed limit sign locations, for each length of road to which a variable speed limit applies;
- d. two “Standard” (R1-1) or “100 km/h” (R1-1.1) speed limit signs at the end of a section of road to which a variable speed limit applies, facing road users leaving the variable speed limit and showing the permanent speed limit that applies to the road beyond that point; and
- e. all “Variable speed” signs installed after the date of publication of this notice must be R1-2.1 Option B signs as specified in Schedule 1 of the Land Transport Rule: Traffic Control Devices 2004.

## 4. Speed Limit May Apply to Part of the Road

The variable speed limit that applies at any time may apply to all of the sections of State Highways 1 and 2 described in Condition 2 of this notice or may apply to any length of road within those sections, bounded by the location of the speed limit signs.

## 5. Speed Limit Displayed on Signs

The speed limit that applies to a length of road at any time must be displayed on the variable speed limit signs within that length of road, except for a speed limit of 100km/h, which may be indicated by blank variable speed limit signs.

## 6. Recording Changes in Speed Limit

Records must be kept to show the actual speed limit that applied to any particular length of road at any time. The records must be available for public inspection and include the time the speed limit changed, the date, the speed limit and a description of the beginning and end points of the length of road to which the speed limit applied.

## 7. Bylaw

The NZ Transport Agency (Highways and Network Operations Group) must set the variable speed limit by making a bylaw in accordance with the Land Transport Rule: Setting of Speed Limits 2003.

## **Rural Intersection Active Warning System Variable Speed Limit—State Highway 1, Moeraki Boulders Road Intersection, Moeraki**

Pursuant to clause 6.1 of the Land Transport Rule: Setting of Speed Limits 2003 and clause 4.4(4) of the Land Transport Rule: Traffic Control Devices 2004 and delegations from the NZ Transport Agency, I, Glenn Bunting, Network Manager, approve a rural intersection active warning system variable speed limit on State Highway 1 at the intersection with Moeraki Boulders Road at Moeraki, to manage the safety of traffic when vehicles are turning at the intersection, in accordance with the conditions set out in this notice.

### **Conditions**

#### **1. Variable Speed Limit**

The NZ Transport Agency (Highways and Network Operations Group) may set a variable speed limit that is:

- a. 70km/h, if the permanent speed limit on State Highway 1 at the intersection with Moeraki Boulders Road is 100km/h; or
- b. 60km/h if the permanent speed limit on State Highway 1 at the intersection with Moeraki Boulders Road is 80km/h.

#### **2. Operation of the Variable Speed Limit**

The variable speed limit, which must be displayed on variable speed limit signs, may operate when a vehicle is detected approaching the intersection on Moeraki Boulders Road or turning right on State Highway 1 and may continue to operate until those vehicles have cleared the intersection. When the variable speed limit is not operating, the variable speed limit signs must either display the permanent speed limit or be blank.

#### **3. Signs**

Speed limit signs that comply with the Land Transport Rule: Traffic Control Devices 2004 must be installed to identify the section of road subject to the variable speed limit as follows:

- a. At least one R1-2.1, Option B “Variable speed” sign, capable of displaying both “60” and “70”, installed above a W15-1 (railway crossing on controlled side road) warning sign, at the beginning of the variable speed limit on State Highway 1, facing road users on each approach to the intersection with Moeraki Boulders Road; and
- b. R1-1 “Standard”, R1-1.1 “100km/h” or R1-3 “Derestriction” signs at the end of the variable speed limit, facing road users on each road that leaves the intersection, to indicate the permanent speed limit that applies beyond that point.

#### **4. Length of Variable Speed Limit**

The variable speed limit on State Highway 1 must be a minimum length of 300m, but must not be longer than 500m.

#### **5. Bylaw**

The NZ Transport Agency (Highways and Network Operations Group) must set the variable speed limit by making a bylaw in accordance with the Land Transport Rule: Setting of Speed Limits 2003.
