#### **Notice**

- 1. Title—(1) This notice is the Primary Maternity Services Amendment Notice 2017.
- (2) In this notice, the Primary Maternity Services Notice 2007, which was published as a Supplement to the <u>New Zealand Gazette</u>, 13 April 2007, No. 41, page 1025, and became effective from 1 July 2007, is called the **principal notice**.
- 2. Commencement—This notice comes into force on 1 May 2017.
- **3.** Amendment—The principal notice is amended by revoking Schedule 1 and substituting the new Schedule 1 set out in the Schedule to this notice.
- **4. Transitional provision relating to implementation of amendment**—(1) The default transitional provisions in clause A12 of the principal notice apply to this amendment.
- (2) For the purposes of applying the default transitional provisions, the implementation date for this amendment is 1 July 2016.
- (3) Pursuant to clause A12(5) of the principal notice, if the applicable date of service for a payment to a maternity provider occurs on or after the implementation date of 1 July 2016, the amended fees specified in this notice will apply.

# Prescribed Classes of Registration for Electrical Workers Including Limits of Work in Respect of Each Class and Requirements/Standards for Registration

The Electrical Workers Registration Board ("Board") has responsibility for the registration and licensing of electrical workers. The Gazette Notice titled "Prescribed Classes of Registration for Electrical Workers Including Requirements/Standards for Registration, and Limits of Work in Respect of Each Class", published in the <a href="New Zealand Gazette">New Zealand Gazette</a>, 1 April 2010, No. 39, page 1098, provided for the classes of registration for electrical workers, the requirements/standards for registration, and limits of work in respect of each class of registration. That notice is hereby revoked.

In accordance with sections 84, 85, and 86 of the Electricity Act 1992 ("Act"), the Board gives notice of the following:

- The classes of registration under section 84(1)(a) of the Act are those set out in Table One of this notice;
- the requirements/standards for registration under sections 85 and 86 of the Act in each of the classes of registration are those set out in Table Two of this notice;
- the types of prescribed electrical work each class of registration is authorised to do, or assist in doing (when licensed) under section 84(1)(b) of the Act are set out in Table Three of this notice; and
- the commencement of this notice is six months from the date this notice is gazetted.

#### **Definitions**

2017-go1973

Terms used in this notice that are defined in either the Electricity Act 1992 or the Electricity (Safety) Regulations 2010 have the meanings provided in those legislative instruments.

PEW means prescribed electrical work as defined in the Electricity (Safety) Regulations 2010.

Qualified Engineer means a person who, by reason of qualifications in electrical engineering:

- is registered under the Engineering Associates Act 1961 and was so registered immediately before 1 April 1993; or
- was registered under the Engineers Registration Act 1924 immediately before 1 April 1993 and was also so registered immediately before the end of the transitional period (as defined in section 4 of the Chartered Professional Engineers of New Zealand Act 2002).

**Chartered Professional Engineer** means a person entitled to that designation under the provisions of the Chartered Professional Engineers of New Zealand Act 2002.

#### Prescribed Requirements Relating to the Completion of Competence Programmes in Respect of Persons Applying for Practising Licences or Applying for Renewals of Practising Licences

The Electrical Workers Registration Board ("Board") has responsibility for the registration and licensing of electrical workers.

The notice published in the <u>New Zealand Gazette</u>, <u>9 April 2015</u>, <u>Issue No. 36</u>, <u>Notice No. 2015-go2035</u>, sets out the requirements relating to the completion of Competence Programmes in respect of persons applying for practising licences or applying for renewals of practising licences. That notice is hereby revoked.

Concurrent with the publication of this notice the Board published a notice prescribing the classes of registration for electrical workers including limits of work in respect of each class and requirements/standards for registration (as published in the <u>New Zealand Gazette</u>, 27 April 2017, Issue No. 45, Notice No. 2017-go1984 ("Prescribed Classes of Registration Gazette Notice")).

The Prescribed Classes of Registration Gazette Notice creates new classes of registration and changes some of the existing classes of registration. To align with those changes it is necessary that the requirements relating to the completion of Competence Programmes be amended.

This notice does not change the Competence Programme requirements. It only establishes the Competence Programme requirements for the new or changed classes of registration.

The requirements relating to the completion of Competence Programmes, in respect of persons applying for practising licences or applying for renewals of practising licences, come into force six months from the date that this notice is gazette. These requirements are set out in the Schedules below.

Subject material for the electrical safety aspect of Competence Programmes and Professional Development Programmes: • The required subject material of the electrical safety aspect of a Competence Programme or a Professional Development Programme is set out in Schedule 2 below. Subject material for the basic first aid and cardio-pulmonary resuscitation aspect of Competence Programmes or a Professional Development Programme: Instruction in cardio-pulmonary resuscitation must be provided so as to achieve the CPRL2 requirements of the New Zealand Resuscitation Council. First aid instruction must be provided in accordance with material published by either the New Zealand Red Cross or St John New Zealand. Provided that is the case, the subject material of those courses of instruction will be deemed to be approved by the Board.
